- My first monography was published in October in 2023 at the well-established French publisher <u>Éditions Stock</u>. This book investigates how one painkiller (Spasfon, or phloroglucinol) became one of the most prescribed pharmaceutical drugs to women in France, reimbursed by the French health system, yet without much clear evidence in its favour. The goal of this book is to empower the public and especially women when navigating the French health system. Based on the analysis of the archival documents from the 1960s surrounding the making of this drug as well as contemporary data, I argue that it should be discarded on both epistemological and ethical grounds. This book demonstrates how pervasive and rampant sexism still remain in French medicine.
